Your signature below signifies receipt of the foregoing disclosure.

I understand that any offer of employment with Eldora Mountain Resort is contingent upon my passing any required physical examinations. I acknowledge that it is the policy of Eldora Mountain Resort that applicants for certain positions must submit a sample of urine for chemical or other analysis. I further understand that the purpose of this analysis is to determine or rule out the presence of non-prescribed or prohibited controlled substances in my urine. I hereby consent to this request for a urine sample and agree to participate in the testing program.

In consideration of my employment, I agree to comply with the policies, rules, regulations, and procedures of Eldora Mountain Resort. I understand that I do not have a Contract of Employment with Eldora Mountain Resort; that my employment will be at-will and is not for a definite duration; and that my employment can be terminated with or without cause or notice, at any time, at the option of either Eldora Mountain Resort or myself.
